

## Sand Lake Garden Club

### January 26, 2023 – Annual Member Meeting Minutes

President Sally Perry welcomed our members and guests to the meeting.

Our Program **“Soil testing and how to buy soil”** was presented by:

David Chinery, the Senior Resource Extension Educator for the Cornell Cooperative Extension of Rensselaer County.

After several comments and questions from the members, President Sally Perry thanked David Chinery for an informative and enjoyable presentation.

The Business Meeting was then called to order at 7:35 PM, with approximately 23 members in attendance.

Treasurer’s Report – Hollis McEvelly  
Balance as of 1/26/23 - \$6,423.15

Joan Gross reported that the 2022 audit has been completed and all figures are accurate.

The 2023 Budget was presented, indicating figures with and without a Garden Faire. The final budget will be presented at the February Meeting.

The board voted on the \$15.00 increase in dues at our board meeting, due to the rise in speaker fees, insurance, administrative fees, town hall rental from \$15.00 to \$25.00/month and no increase in dues in many years. Janice Berryann made a motion to allow for a hardship fee of \$10.00 if asked, Pat Mulligan seconded the motion.

There was discussion on raising the scholarship to \$600.00. Joan Gross indicated it will be considered, saying we need to be conservative if the Garden Faire does not take place this year and if membership dwindles due to increase in membership fees. The \$500.00 scholarship was increased to \$600.00 last year due to speakers donating back their speaker fees.

Sally Perry handed out a form on Garden Faire assignments, as well as Committee Interest forms. These forms will also be emailed to members. Sally has asked

members to look them over and see what interests you. When looking over these forms, think about teaming up with someone and in doing such we can divide and conquer the Garden Faire this year. Members have been asked to mail or email them back. The tentative date for the Garden Faire is May 20<sup>th</sup>, 2023. Considering that Cornell Cooperative is having their Spring Garden Day in March, they may or may not join the Garden Faire this year, they are still considering this.

Janice Berryann had asked about bringing door prizes back to the monthly meetings, she indicated she would be happy to be in charge, Joan Grusensky also indicated that she would be happy to help. It was something she and others thought was a nice addition to the monthly meetings. We will be looking forward to this at our February meeting.
